## **Preface**

Volume 23 of the Yearbook of Islamic and Middle Eastern Law covers the period from 2022 to 2023. As has become by now tragically familiar, this volume goes to print before the background of war and widespread human suffering in many of the countries and regions covered by the Yearbook. At the time of writing this Preface, Palestine, Lebanon and Israel are all witnessing deaths and destruction on an unprecedented scale, with the risk of further regional escalation rising by the day. Many other countries in the Middle East and North Africa continue to be exposed to armed conflict, extreme weather events and economic hardships. The civil war in Sudan continues unabated whilst in Yemen, Houthi attacks against a number of naval and merchant ships as well as targets in Israel itself have been met with military action under the United States-led Operation Prosperity Guardian, following on from the adoption UN Security Council's Resolution 2722 (2024), demanding that Houthis immediately stop attacks on merchant, commercial vessels in the Red Sea.

Turning to the content of this year's volume, I note with much saddness and a heavy heart the passing of Professor M.A. Ansaripour in June 2023. As a member of the University of Tehran, Professor M.A. Ansaripour was one of the longest serving contributors of country surveys to the *Yearbook*, having filed surveys on the legal developments in the Islamic Republic of Iran in every single volume of YIMEL, starting with volume 1 in 1994. For the Iran survey of volume 22 of YIMEL, Professor M.A. Ansaripour had been joined by his PhD student Dr. Ahmad Mohammadi. In addition to his regular in-depth and highly informative surveys on Iranian legal developments, Professor M.A. Ansaripour also authored and published a number of insightful and thoughtprovoking research articles on wide range of subjects in the *Yearbook*. Professor M.A. Ansaripour's contributuons to legal scholarship will be greatly missed and all members of the editorial team of YIMEL convey their heartfelt confolences to his family, colleagues, and students.

Volume 23 of the Yearbook continues to benefit from a number of specialist and general surveys on legal developments in the Middle East and in a number of jursidctions of the Islamic world. I am grateful to the estemmed contributor of surveys on *Afghanistan* (Haroun Rahimi), *Algeria* (Ammar Belhimmer and translated by Prof Baudouin Dupret), *Bahrain* (Raed Alnimer), *Egypt* (Noha Khaled and Prof Mohamed S. Wahab, *Jordan* (Kamal Alawamleh and Ali Mohamad Aldabbas), *Kuwait* (Fahad Ali Alzumai), *Libya* (Gofran Abaoub and Adam Abouda), *Malaysia* (Ummi Hani Binti Masood), *Saudi Arabia* (Beata Maria Polok), *Türkiye* (Deniz Tekin-Apaydin), the *United Arab Emirates* (Dr Gordon Blanke and Farhan Shafi), as well as the survey on *Recent Developments*

concerning the Rights of Migrant Workers and of Women: A survey of the Gulf Cooperation Council (GCC) states Oman, Saudi Arabia and the UAE, authored by Radhika Kanchana. Produced by leading practitioners and academics, the country surveys published in this volume, as well as those in the past, are authored within a very short period of time and submitted and edited to very tight deadlines. By way of this Preface, and on behalf of the entire editorial team, I thank all the authors and contributors of country surveys for their valued contributions, in the hope and expectation of their continued support for future volumes of the Yearbook.

Four of the articles published in volume 23 of the *Yearbook* form part of the *Special Edition: Succession in Islamic Law*. Edited by Professor Dr Nadjma Yassari, Director of the *Swiss Institute of Comparative Law* in Lausanne, Switzerland, this Special Edition emanates from the proceedings of the international conference on *Succession in Islamic Law* that took place at the *Max Planck Institute for Comparative and International Private Law* in Hamburg in March 2023. I refer with many thanks to Professor Yassari's highly informative Preface to the Special Edition in Part 2 as well as the valuable scholarly contributions published in Part 2 of this volume.

Five further articles, already published in <code>YIMEL</code>'s on-line version, are included in volume 23.
